## **Manager Going to Jail**

The message from regulators couldn't be more clear: If you don't provide workers with the necessary PPE, it's not just your company that might be on the hook.

Individuals could face jail time. The most recent company leaders to learn that lesson: Five managers at A&E Salvage who instructed workers to remove asbestos-containing materials from a closed plant in Hamblen County, TN.

The company didn't train the workers on proper asbestos removal or provide the necessary PPE to protect against the hazard.

Asbestos has been proven as the near-exclusive cause of mesothelioma, a rare and aggressive cancer, as well as asbestosis and lung cancer.

The company leaders pleaded guilty to a criminal felony count of conspiring to violate the Clean Air Act's "work practice standards" for removal and disposal of asbestos.

#### Owners and managers charged

Here are the sentences the managers are slated to serve:

- Mark Sawyer, owner and operator, 5 years in prison followed by 2 years of supervised release
- Newell Smith, manager, 37 months (3 years, 1 month) in prison and 2 years of supervised release
- Eric Gruenberg, manager, 28 months (2 years, 4 months) in prison
- Arimida DiSanti, 6 months in prison and 6 months of home confinement, and
- Milto DiSanti, 6 months in prison and 6 months of home confinement.

#### **Millions in restitution**

In addition, the managers were ordered to pay restitution of more than \$10.3 million, which will go straight to the Environmental Protection Agency's Superfund.

This is the fund officials used to pay to clean up the contaminated plant.

#### A 'multi-year scheme'

According to the charges, the managers at A&E Salvage did more than simply forget to provide workers with a pair of gloves before sending them out to the factory.

The Department of Justice called their actions "a multi-year scheme in which substantial amounts of regulated asbestos containing materials were removed."

Expert testimony revealed a serious risk of injury to the workers removing the asbestos.

The FBI recently looked at active shooter incidents in the U.S. between 2000 and 2013 and found that 70% of active shooter incidents happened at either a commercial business or educational institution.

For the purposes of the study, the FBI defined "active shooter" as an individual or individuals actively engaged in killing or attempting to kill people in a confined and populated area or outside a building.

#### **Study findings**

There were 160 incidents that fit these parameters averaging out to 11.4 incidents a year, though that number is rising. The incidents took place in 40 states and Washington, DC. More findings from the study:

- Most of the shooters were young men the shooter was a woman in only six incidents.
- 40% of the shooters committed suicide either on the site of the attack or shortly after the incident.
- The incidents began and ended quickly: 69% of them ended within five minutes, and almost half ended within two minutes.
- 60% of the incidents ended before the police got to the scene.
